PROVIDE EXPLANATION FOR CHANGE:

The New York State Department of Transportation is rolling out two statewide initiatives to mitigate Wrong Way Driving and Bridge Hits at overpasses that do not meet minimum clearance standards. The Wrong Way Driving initiative will address approximately 250 limited access exit ramps with additional signing and possible pavement markings across Region 1. The Low Clearance Bridge initiative will upgrade signs to meet new guidelines for additional signs and upgraded reflectivity. The costs associated reflect the Region 1 project totals and a portion will be spent within the CDTC area. The Region will commence the project at the detail design phase, as preliminary design is being taken care of statewide. Due to the similar work associated with both initiatives, Region 1 intends to deliver the work in one contract.
