The following Roadway Departure Safety Improvements applications for the Roadway Departure Safety Action Plan Local Call for Projects have been selected for funding. This is a request to add the new projects to the TIP.

1. For 1763.74 (Albany County), the Highway Safety Improvement Program (HSIP) funding awarded is limited to \$1,463,000 with a total project cost of \$1,540,000.
2. For PIN 1763.75 (Town of Guilderland), the HSIP funding awarded is limited to \$356,234 with a total project cost of \$374,983.

3. For PIN 1763.76 (Town of Halfmoon), the HSIP funding awarded is limited to \$552,900 with a total project cost of \$582,000.
4. For PIN 1763.77 (Town of Wilton), the HSIP funding awarded is limited to \$1,586,500 with a total project cost of \$1,670,000.
