Project Description

The scope of the work includes replacing the 6' concrete sidewalks where they are distressed on the North side of Sand Creek Road, and the addition of concrete sidewalks on the South side of Sand Creek Road where they currently do not exist. With the improvements made to the sidewalks, the work would also include curb ramps and the addition of detectable warning units. To increase safety and awareness for bicyclists that wish to use the corridor, striping is included in this project. Grass restoration and driveway apron reconstruction for affected properties is recommended, as well as new and replacement drainage and pipes along the corridor. These improvements would begin at 601 Sand Creek Road, and continue to the cross street of Jodiro Lane, covering approximately 1.2 miles of roadway.

Project Description

The Village will install/replace nearly a total of 4,000 sq. ft of sidewalks with and without curbing and include ADA compliant pedestrian ramps on significant Village segments along Mountainview and North Main Streets. New crosswalks and signage will also be included in the Project scope specifically to Mountainview Street. Mountainview Street is between Maple Avenue and Stonington Hill Road with minimal to no sidewalks on either side. The project will involve installing, with and without curbing, approximately 1,300 feet of sidewalks between both sides of the roadway, beginning on the west side (approximately 550 feet) from Maple Avenue to the existing church parking lot. A crosswalk will be installed in front of the church to allow pedestrians to cross Mountainview Street safely and continue onto further installed sidewalks (approximately 650 feet) to reach Stonington Hill Road. The posted speed limit in the vicinity of the crosswalk is 30 mph with a 20-mph school zone, but 90% of vehicles drive above the speed limits during the School Zone Hours (7:00 AM-5:00 PM) at this location. The proposed Project will remove and relocate the existing crosswalk and Back-to-School signage to Mountainview Street to increase the separation from the adjacent signal to greater than 200 feet, the urban minimum recommendation, and encourage a safer walking network through Mountainview Street to reach the Elementary School. The North Main Street Project segment will be limited to one side of the street; the same side where 630 feet of hazardous sidewalk exists.

Project Description

However, it is primarily a vehicular route. The Project will make the path safer for pedestrians and cyclists. The key destinations for travelers will be: Saratoga Spa State Park, Saratoga State Park's Hemlock Trail parcel, Saratoga Honda, Saratoga Dog Park, Saratoga Casino & Raceway, Housing and the upcoming Tree House Brewing Company which will be a regional tourist draw not unlike the Casino or Race Track.

Project Description

The proposed scope of work would include the installation of pedestrian and bicycling enhancements, including a sidepath, signage, and related infrastructure upgrades along Gilligan Road in accordance with the design phase of the project. The Town received funding through the previous TIP solicitation for the design of the project, therefore this scope of work would include the only the construction of the improvements set forth in the design phase (anticipated commencement of design in December of 2024). Proposed is the construction of an approx. 10' sidepath along the corridor, along with the installation of enhanced pedestrian safety measures, including raised crosswalks and solar-powered Rectangular Rapid Flashing Beacons (RRFBs) at both Ternan Avenue intersections on Gilligan Road. Also proposed is the installation of all relevant landscaping, lighting, and drainage improvements as required in accordance with the construction of the proposed sidepath and pedestrian safety measures.

Project Description

The project will construct the last segment of the Zim Smith Trail from the current terminus at Oak Street in Ballston Spa to E West Road in Saratoga Spa State Park. The northern extension of the trail will add approximately 4 miles of 10-foot wide paved surface. The trail will extend through five communities; the Village of Ballston Spa, the Towns of Ballston, Milton, and Malta, and the City of Saratoga Springs. The trail will cross the Kayaderosseras with a new pedestrian/bicycle bridge within a floodway. The County desires to construct a trailhead near E High Street with parking and other trail amenities. This new parking location would hopefully alleviate historic concerns of Oak Street residents with on-street trail user parking.

Project Description

The project involves the extension of the Village sidewalk network along Main Street (NYS Route 40/67) to connect the Hoosic Valley Shop & Save and the Hoosic Valley Central School campus. This extension is designed to enhance pedestrian safety and improve access to key community destinations, such as the school, Schaghticoke Fairgrounds, and nearby businesses, including the Hoosic Valley Shop & Save grocery store. The sidewalk will begin at the existing network on the east side of Main Street and extend north along the roadway within the NYSDOT Highway Boundary. It will then turn east through a designated easement area adjacent to the Hoosic Valley Shop & Save parking lot. An easement will be secured to ensure the sidewalk passes beside the parking lot, maintaining a continuous pedestrian path. Additionally, the sidewalk will connect directly to the Hoosic Valley Central School campus, providing a safer route for students, faculty, and visitors. Two crosswalks will be introduced as part of the project to improve pedestrian safety. One will cross Main Street to provide access to the Schaghticoke Fairgrounds entrance, and include equipped RRFB's to alert motorists of the pedestrian crossing. The second crosswalk will connect the sidewalk to the existing sidewalk within the Shop & Save parking lot, facilitating safer movement across the area. The project will also address safety concerns related to large semi-trailer truck parking in the school's baseball field parking area. As part of the design process, existing drainage structures along the proposed sidewalk route will be evaluated.
