Dear Ms. Misiewicz:

CDTA is submitting the proposed amendments to the 2025-2023 Capital Region Transportation Council TIP for consideration by the Planning Committee at its next scheduled meeting.

The numbers listed in the TIP for 5307 and 5339 funding sources are estimated based on historical information. The proposed amendments reflect the SFY 2026-27 CDTA budget approved at the March 25, 2026 CDTA Board Meeting and the FTA FFY 2026 apportionments published March 31, 2026. CDTA is required to submit federal grant applications in June and July, so we are requesting a TIP update prior to grant submittal. Changes are highlighted in yellow.

**TIP PROJECT NUMBER: T6B (1824.94) – STAR Bus Replacement and Expansion**

**TIP PROJECT NUMBER: T140 (CDTA.03) – FLEX Microtransit Vehicle Replacement / Expansion**

The amendment is proposed due to the following:

**Provide Explanation for Change**

This change requests to combine T6B (1824.94) and T140 (CDTA.03) into one project as we begin to transition to a combined fleet for vehicles used for the STAR paratransit service and the FLEX On Demand microtransit service to allow for more flexibility based on service demands. The request also updates the funding source from Section 5307 to Section 5339 for FFY 2026. Additionally, CDTA requests

to update the project description to allow for up to 10% of total project cost for Project Administration, as allowable under FTA Circular 9050.1A. The total cost of the two separate projects is equal to the cost of the combined PIN.

**UPDATED TIP T6B (PIN 1824.94) – Paratransit/Microtransit Vehicle Replacement / Expansion**

Purchase of custom vehicles for STAR (Special Transit Service Available by Request) and Flex On Demand Microtransit services. Includes funds for replacement or expansion of the combined fleet. Project Administration up to 10% of total project cost.

**Provide Explanation for Change**

The following project is created by the reprogramming of flexed FHWA funds previously programmed to the BusPlus Red Line Upgrades project. That project received additional competitive funding through the Safe Streets and Roads for All program, so project progression using FHWA funds has been delayed. These funds have not yet been put into a grant, so CDTA requests to reprogram these older funds to a project that is ready to progress. Necessary additional funds for the Red Line can be added later.

**TIP T167 (CDTA.17) NEW – Intelligent Mobility**

This project includes new traffic operations software (TraffOp), analytics software (Miovision One/Mateo), and a new maintenance services agreement to support CDTA's continuous improvement and optimization of traffic signal priority and queue jumper investments throughout the Capital Region. Project Administration up to 10% of total project cost.
